PRECAUTIONARY STATEMENTS

FIRST AID

GENERAL INFORMATION

TIGRIS Crop Oil is a non-ionic blend of highly refined paraffinic crop oil and surfactant designed to optimize the performance of certain herbicides in post emergence applications. The addition of this product to the spray tank utilizes the penetrating, non-evaporating properties of a paraffinic crop oil and the wetting and dispersing characteristics of a surfactant blend. When used as directed, **TIGRIS Crop Oil** increases the activity of herbicides by aiding in the deposition, absorption and retention of active ingredients on leaf and stem surfaces. Therefore, care must be taken in treating crops during periods when plants are subjected to drought stress, high temperatures, and high humidity. NOT FOR AQUATIC USE IN CALIFORNIA OR WASHINGTON STATE.

DIRECTIONS FOR USE

REFER TO HERBICIDE LABEL FOR SPECIFIC CROP USE AND APPLICATION RATES. Prior to use, read and follow all directions on this label and on the label of the herbicide being used. The herbicide manufacturer's label for specific usages and restrictions have precedence over DIRECTIONS FOR USE referred to on this label. Generally, use 1–4 quarts in 15–50 gallons of water. Do not exceed 2.5% by volume of spray solution. For best mixing results, fill the spray tank half full, add herbicide components, and add **TIGRIS Crop Oil** last and provide good agitation until tank is full.

ENVIRONMENTAL HAZARDS: Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when cleaning equipment or disposing of equipment wash waters.

STORAGE AND DISPOSAL INFORMATION

STORAGE: Store product in original container and keep container tightly closed when not in use. Take care to prevent water from being introduced to the contents of this container. Keep away from sparks, flame, static electricity or other ignition sources. Shake well before use and keep from freezing.

DISPOSAL: Do not contaminate water, food, or feed by storage or disposal. Triple rinse container and pour rinsate into spray tank. Do not reuse container. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
